

Free transportation to and from medical appointments plus grocery delivery to hundreds of homebound seniors

A Year Like No Other

In 2020, SilverSource delivered groceries to 320 older residents, creating a lifeline to provide enough food for more than 250,000 meals.

Within hours, our Conference Room was transformed into a Food Pantry, as Staff and Volunteers joined forces to get life-sustaining groceries to seniors throughout Stamford – providing a lifeline to those with no other means to secure food and remain safely at home.

Thanks to Our Amazing Volunteers

More than 120 Volunteers stepped up to assist SilverSource to provide a lifeline to our older neighbors through the height of the pandemic, enabling them to stay home and stay safe. Staff and Volunteers made Well-Check Calls to some 2,000 seniors to meet their urgent needs, ensure they had enough food and medicine to sustain them, and reduce isolation. Our Ride to Wellness program also continued to provide safe, cost-free transportation to essential medical procedures such as dialysis and chemotherapy.

During the pandemic, we focused on doing all that we could to help seniors stay safely at home, making sure they had enough food and medications from week to week. Fresh milk, eggs, produce and basics were gathered from wholesale suppliers, community donations, food banks, food drives and friends. In 2020-21, we provided enough food for 250,000 meals through our Grocery Delivery program.

SilverSource has broad and deep experience in caring for the needs of older adults in our community, having done so for more than a century. True to our mission, we provide a safety net to seniors in need to keep a roof over their heads, the heat and lights on, food on the table and the medical care they need. As life returns to normal, our Social Work team continues to serve at-risk elderly residents with financial support to meet urgent needs around housing, heat, health and hunger.

The past year has been one of unique inspiration, witnessing the endless acts of selflessness and determination performed daily by so many in our community. It has also been one of profound reflection and loss, as we lost beloved clients and loved ones during this time. Looking back on the past 15 months, we marvel at the outpouring of support we received from throughout the community that made it possible for us to accomplish what seemed impossible. We also celebrate the wonderful relationships we built and strengthened during the crisis, and express our gratitude to the leaders of the City of Stamford, and our colleagues, board members and community partners. Their steadfast commitment, courage, tireless effort and support made it possible for us to care for seniors throughout.

In this extraordinary year, we were also proud to recognize an unprecedented seven community leaders with 2021 SilverSource Awards. We congratulate them all for their exceptional leadership and service in the face of such daunting challenges.

Your support provided


\$74,548 for medical costs, including prescriptions, eye care, hearing aids and home care for 286 seniors in need.
